- Release 254 of Bender's Immigration Regulations Service includes regulatory changes published in the Federal Register from July 20, 2022 through September 21, 2022.
- The release also adds 45 CFR Parts 400–402 and 411, all concerning the DHHS Office of Refugee Resettlement.
