Significant chapter revisions include:

Chapter 1, *Description of Industry:* Chapter 1 contains updated analysis of statutory definitions under the Interstate Commerce Act. (§ 1.06).

Chapter 22, *Freight Charge Liability,* contains new information regarding the liability of a consignee for freight charges and the statutory provisions regarding liability for the payment of freight. (§§ 22.01, 22.03, 22.05).

Chapter 25, *Demurrage and Detention Charges,* has been updated to include new content on demurrage charges on a quantum meruit theory, the statutory requirement to recover demurrage, time limits for recovering demurrage, and the duty to mitigate demurrage damages. (§ 25.01).

This release also contains numerous updates to Chapters 40 thru 56.
