- See new 22 C.F.R. § 62.17, as added by 72 FR 61801, Nov. 1, 2007, eff. Dec. 3, 2007 (Final Rule, Exchange Visitor Program—Fees and Charges for Exchange Visitor Program Services. The same final rule removed 22 C.F.R. Subpart H, Fees, which consisted of 22 C.F.R. § 62.90, Fees).
