Recent Changes

- This release includes recent changes to the regulations published in the Federal Register through December 31, 2007.

Vol. 1: DHS/USCIS

- The table at 8 C.F.R. § 299.1, Prescribed Forms, has been updated to reflect the addition of line items for forms I-800 and I-800A.

Vol. 2: Department of State

- The table at 22 C.F.R. § 22.1, Schedule of Fees, has been updated to reflect changes at Item 9, Passport Services; Item 21, Non-immigrant visa application and border crossing card processing fees (per person); Item 32, Immigrant visa application processing fee (per person); and Item 35,

Special visa services (removal of Item 35(f)).

- 22 C.F.R. Part 51, Passports, reflects changes made by the Department of State at 72 FR 64930, Nov. 19, 2007, eff. Feb. 1, 2008. In addition, further changes in Part 51 were made to 22 C.F.R. §§ 51.3 (Types of passports), 51.4 (Validity of passports), and 51.52 (Exemption from payment of passport fees), at 72 FR 74169, Dec. 31, 2007, eff. Feb. 1, 2008.
- 22 C.F.R. Part 62, Exchange Visitor Program Services, reflects changes made in § 62.50 (Sanctions), and in §§ 62.60 through 62.63 (relating to termination and revocation of programs), made by the Department of State at 72 FR 72245, Dec. 20, 2007, eff. Jan. 22, 2008.
