Feb. 1, 2008. This was a correction to the Department of State's passport rule published at 72 FR 74169, Dec. 31, 2007, eff. Feb. 1, 2008. The text as amended by that rule appeared in Release 182.
- **22 C.F.R. §§ 51.1 and 51.51.** 22 C.F.R. §§ 51.1 and 51.51 reflect corrections made by Department of State at 73 FR 5435, Jan. 30, 2008. This was a correction to a

Department of State final rule published at 72 FR 64930, Nov. 19, 2008. The text as amended by that final rule appeared in Release 182.

- **22 C.F.R. § 51.21, Passport Application (correction by DOS).** 22 C.F.R. § 51.21(b) & (c) reflect a correction published by Department of State at 73 FR 4077, Jan. 24, 2008, eff. Feb. 1, 2007. This was a correction to a Department of State final rule published at 72 FR 64930, Nov. 19, 2007, eff. Feb. 1, 2008. The text as amended by that final rule appeared in Release 182.
