HIGHLIGHTS

Recent Changes

- This release includes recent changes to the regulations published in the Federal Register through February 25, 2008.

DHS Regulations (Vol. 1)

- **8 CFR Part 274 amended by DHS Interim Rule, Administrative Process for Seizures and Forfeitures Under the Immigration and Nationality Act and Other Authorities, 73 FR 9010, Feb. 19, 2008.** The DHS Interim Rule made revisions to 8 CFR §§ 274.1 and 274.2, and it removed 8 CFR §§ 274.3 to 274.20. The amendments consolidate the procedures for administrative sei-

zure and forfeiture process. Accordingly, 8 CFR part 274 is amended to reference CFR Title 19 with respect to administrative seizure and forfeiture processes.

DOS Regulations (Vol. 2)

- **Color Photograph Requirement for Diversity Immigrant Visa Application, DOS Final Rule, 73 FR 7670, Feb. 11, 2008.** The DOS final rule revises 22 CFR § 42.33, Diversity Immigrants, at subsec. (b)(2)(iii), to require that photographs be in color. The rule notes in the preamble that color photographs enhance facial recognition and reduce the opportunity for fraud.
