- **Establishment of Genealogy Program.** DHS final rule, May 15, 2008, 73 FR 28026, effective Aug. 13, 2008, established a fee-for-service Genealogy Program within USCIS to streamline and improve the process for acquiring historical records of deceased individuals. Four new sections are added to 8 CFR Part 103 to implement the program:
