### RECENT CHANGES

- This release includes recent changes to the regulations published in the Federal Register through July 7, 2008.

### VOLUME 1

#### ***DHS & DOJ REGULATIONS (8 CFR)***

##### **Changes to the Visa Waiver Program To Implement the Electronic System for Travel Authorization (ESTA) Program**

- A new § 217.5, Electronic System for Travel Authorization, was added by DHS interim final rule, 73 FR 32440, June 9, 2008, effective August 8, 2008.

##### **BIA: Composition of Board and Temporary Board Members; Interim Rule of Dec. 7, 2006, Adopted As Final Without Change**

- The EOIR interim rule (71 FR 70855, Dec. 7, 2006) amending 8 CFR § 1003.1 to increase the Board from 11 to 15 members, and amending the authority of the Di-

rector to appoint temporary Board members, was adopted as final without change at 73 FR 33875, June 16, 2008.

##### **Documents Required for Travelers Departing From or Arriving in the United States Within the Western Hemisphere**

- In Release 186 (May 2008), to reflect a joint DHS/DOS final rule published on April 3, 2008 (73 FR 18384), footnotes were added at affected section locations advising that those sections had been added or amended prospectively, not effective until June 1, 2009, and indicating that those sections would be updated with the amended text at the appropriate time. Those footnotes have now been enhanced to include the amended text. Concerning the affected sections in 8 CFR, see §§ 212.0, 212.1, 235.1.

#### ***DOS REGULATIONS (22 CFR)***

##### **Exchange Visitor Program—Au Pairs**

- Section 62.31, Au Pairs, at sub-

section (p), Repeat Participation, was amended by DOS interim rule, 73 FR 34861, June 19, 2008 (as corrected 73 FR 36789, June 30, 2008), eff. July 21, 2008.

**Exchange Visitor Program—College and University Students, Student Interns**

- Section 62.23, College and University Students, was amended by DOS final rule, 73 FR 35066, June 20, 2008, eff. July 21, 2008, to reflect creation of the new subcategory for Student Interns.

**Documents Required for Travelers Departing From or Arriving in the United States Within the Western Hemisphere**

- In Release 186 (May 2008), to reflect a joint DHS/DOS final rule published on April 3, 2008 (73 FR 18384), footnotes were added at affected section locations advising that those sections had been added or amended prospectively, not ef-

fective until June 1, 2009, and indicating that those sections would be updated with the amended text at the appropriate time. Those footnotes have now been enhanced to include the amended text. Concerning the affected sections in 22 CFR, see §§ 41.0, 41.1(b), 41.2, and 53.2.
