DHS & DOJ REGULATIONS (8 CFR)

- There were no changes to the DHS or DOJ Regulations in Volume 1 subsequent to those covered in the previous release (Rel. 188, July 2008).

VOLUME 2

DOS REGULATIONS (22 CFR)

22 CFR Part 7, Board of Appellate Review (Removed & Reserved); Procedures for Review Loss of Nationality

- By an Interim Final Rule published at 73 FR 41256, July 18, 2008, the Department of State removed and reserved 22 CFR Part 7, Board of Appellate Review. In connection with the removal of those provisions, the Department also completely revised 22 CFR § 50.51 (Review of finding of loss of nationality). It was noted in the preamble to the rule that the Board's jurisdiction has been superseded or made obsolete for several years.
