VOLUME 1

DHS & DOJ REGULATIONS (8 CFR)

- There were no changes to the DHS or DOJ Regulations in Volume 1 during the period covered by this Release No. 190.

VOLUME 2

DOS REGULATIONS (22 CFR)

22 CFR § 40.104—Aliens Inadmissible Under the Immigration and Nationality Act,

as Amended: Unlawful Voters

- The amendment to 22 CFR § 40.104 concerning visa ineligibility for aliens who vote unlawfully, made by DOS *interim* rule on June 21, 2005 (70 FR 35526), was adopted as final without change by DOS *final* rule on August 26, 2008 (73 FR 50194).

22 CFR § 41.105—Documentation of Nonimmigrants Under the Immigration and Nationality Act, as Amended: Fingerprinting

- A new par. (b), Fingerprinting, was added to 22 CFR § 41.105 by DOS final rule on August 20, 2008 (73 FR 49091). As explained in an editorial footnote, a prior par. (b) was removed effective Jan. 1, 2008.
