HIGHLIGHTS

Release 196 follows Release 194 (no Release 195)

- This Release 196 (Mar. 2009) follows immediately after Release 194 (Feb. 2009). There was no intervening Release 195.

INCLUDED IN THIS RELEASE

- Release 196 includes regulatory changes published in the Federal Register as of the issue dated March 10, 2009. This release also expands the coverage of the publication to include provisions from Title 22 CFR (Foreign Relations) relating to the process of inter-country adoption under the Hague Convention.

Volume 1: 8 CFR (Department of Homeland Security Regulations)

Employment Authorization and Verification of Aliens Enlisting in the Armed Forces

Amendments were made by Final Rule,

74 FR 7993, Feb. 23, 2009, to the following:

- **8 CFR § 274a.2 (Verification of identity and employment authorization).** See newly added § 274a.2(b)(1)(v)(A)(7);
- **8 CFR § 274a.12 (Classes of aliens authorized to accept employment).** See newly added 8 CFR § 274a.12(d). Former (d) has been redesignated as (e).

Hague Convention Adoptions
