8 CFR REGULATIONS (VOL. 1)

Designation of Greece for the Visa Waiver Program

See 8 CFR § 217.2(a), enumerating the countries that are referred to as a *designated country*. Greece was added to the listing of designated countries by DHS Final Rule published at 75 FR 15991 (Mar. 31, 2010, eff. Apr. 5, 2010).

DOL REGULATIONS (VOL. 2)

20 CFR § 655.0 (CFR Correction)

By a CFR correction published at 75 FR

16000 (Mar. 31, 2010), the Department of Labor replaced 20 CFR § 655.0 (Scope and purpose of part) in its entirety, including the section history.

Attestation Applications by Facilities Temporarily Employing H-1C Nonimmigrant Foreign Workers as Registered Nurses

A DOL final rule published at 75 FR 10396 (Mar. 5, 2010, eff. Apr. 5, 2010) implements the Nursing Relief for Disadvantaged Areas Reauthorization Act of 2005 (NRDARA), which reauthorized the Nursing Relief for Disadvantaged Areas Act of 1999 (NRDAA), finalizing the rules for enforcement purposes, in relation to facility attestation applications. Amendments were made to Subpart L (20 CFR §§ 655.1100–655.1150) and Subpart M (20 CFR 655.1200–655.1260).
