REGULATORY CHANGES

 Release 211 includes regulatory changes published in the Federal Register as of August 30, 2010.
 See below for details of the changes included in this Release.

DHS Final Rule, Administrative Process for Seizures and Forfeitures Under the Immigration and Nationality Act and Other Authorities; 75 FR 37707, June 30, 2010

• This final rule adopted without change the amendments that were made to 8 CFR Part 274 by DHS interim final rule, 73 FR 9010, Feb. 19, 2008. This is now reflected in the history information for affected sections, which are at 8 CFR Part 274.

DHS-ICE Final Rule, Electronic Signature and Storage of Form I-9, Employment Eligibility Verification; 75 FR 42575, July 22, 2010 [eff. Aug. 23, 2010]

• This final rule amended 8 CFR § 274a.2 (Verification of identity

and employment authorization). As noted in the preamble to the final rule, the amendments were made to provide that employers and recruiters or referrers for a fee who are required to complete and retain the Form I–9, Employment Eligibility Verification, may sign this form electronically and retain this form in an electronic format.

DHS-USCIS Final Rule, Employment Authorization for Dependents of Foreign Officials; 75 FR 47699, Aug. 9, 2010

 This final rule amended 8 CFR § 214.2(a)(2) and (g)(2), adding a new par. (vi) in each instance.

DHS-CBP Interim Final Rule, Electronic System for Travel Authorization (ESTA): Travel Promotion Fee and Fee for Use of the System; 75 FR 47701, Aug. 9, 2010 [eff. Oct. 8, 2010]

• This interim final rule amended 8 CFR § 217.5 by revising par. (a) and adding a new par. (h).

DOS Interim Final Rule, Schedule of Fees for Consular Services, Department of State and Overseas Embassies and Consulates; 75 FR

36522, June 28, 2010, [eff. July 13, 2010]

• This interim final rule made amendments to 22 CFR § 22.1 (Schedule of fees for consular services) and 22 CFR § 51.51 (Passport fees). The schedule of consular fees at 22 CFR § 22.1 was revised in its entirety. The amendment to 22 CFR § 51.1 revised subsection (d), which relates to the surcharge.

DOS Final Rule, Visas: Documentation of Immigrants Under the Immigration and Nationality Act, as Amended; 75 FR 45475, Aug. 3, 2010

• This final rule amended 22 CFR §§ 40.1, 42.63, 42.67, and 42.81, which are sections relating to the application for an immigrant visa and alien registration, to offer a completely electronic application procedure (DS-260, Electronic Application for Immigrant Visa and Alien Registration) as an alternative to submission of Form DS-230, the Application for Immigrant Visa and Alien Registration.

DOS Final Rule, Exchange Visitor Program—Trainees and Interns; 75 FR 48555, Aug. 11, 2010 [eff. Sept. 10, 2010]


 This final rule adopted as final, with certain changes, an interim final published on June 19, 2007 (72 FR 33669), amending 22 CFR § 62.22, Trainees and interns, in its entirety.

DHHS Notice, Delayed 2010 DHHS Poverty Guidelines; 75 FR 45628, Aug. 3, 2010

• As explained in the DHHS notice, the 2010 poverty guidelines were delayed due to legislation prohibiting the Secretary of HHS from publishing 2010 poverty guidelines before May 31, 2010, and requiring that the 2009 poverty guidelines remain in effect until publication of updated guidelines by the Secretary. Revision pages containing the 2010 Poverty Guidelines are included in this Release for insertion into the DHHS Regulations material in Volume 2.
