HIGHLIGHTS

REGULATORY CHANGES

- Release 215 includes regulatory changes published in the Federal Register as of July 11, 2011.

8 CFR Regulations (Volume 1)

- **8 CFR § 274a.2**—Amendment by December 2008 Interim Rule (as corrected) adopted as final without change. The amendments to 8 CFR 274a.2(b) made by Interim Rule, 73 FR 76505, Dec. 17, 2008, together with subsequent corrections to that Interim Rule, were adopted as final by Final Rule, 76 FR 21255, April 15, 2011, eff. May 16, 2011 (with correction to preamble at 76 FR 23861, Apr. 29, 2011).
- **8 CFR § 204.1** amended (General information about immediate relative and family-sponsored petitions). This section was amended by revising paragraph (b), which is now entitled "Proper filing", and by removing and reserving former pars. (c), (d), and (e). These amendments were made by Final Rule with request for comments,

76 FR 28303, May 17, 2011, eff. Aug. 15, 2011.

- **Certain Libyan F-1 Nonimmigrant Students; Notice of Suspension of Certain Requirements Under 8 CFR § 214.2.** See footnote at 8 CFR § 214.2(f)(9) for reference which has been added with respect to the notice published in Federal Register, 76 FR 33970, June 10, 2011, concerning suspension of certain requirements with respect to Libyan F-1's experiencing severe economic hardship as direct result of civil unrest in Libya since February 2011.

DOS Regulations (Volume 2)

- **Exchange Visitor Program—Summer Work Travel.** 22 CFR § 62.32 was revised in its entirety by Interim Final Rule, 76 FR 23177, Apr. 26, 2011, eff. July 15, 2011.
- **Documentation of nonimmigrants, 22 CFR § 41.122 (Revocation of visas); Documentation of immigrants, § 42.82 (Revocation of visas).** These two sections were revised in their entirety by Final Rule, 76 FR 23477, Apr. 27, 2011.

- **Exchange Visitor Program; J-1 Libyan Students; Notice of Suspension of Certain Requirements.** See footnote at 22 CFR § 62.23 for added text of DOS notice published in the Federal Register, 76 FR 33993, June 10, 2011, concerning suspension of certain requirements with respect to J-1 Libyan students to mitigate adverse impact on these students due to political turmoil in their home country.
