HIGHLIGHTS

More 22 CFR Regulations Added

- As of this Release 226, Bender's Immigration Regulations Service now includes the complete 22 CFR Parts 96 through 99 (relating to Hague Convention Inter-country Adoption). See below for more information.

Regulatory Changes

- Release No. 226 includes regulatory changes published in the Federal Register as of June 4, 2014. See below for details of what is included in this release.

8 CFR (Volume 1)

U.S. Asia-Pacific Economic Cooperation Business Travel Card Program. See new 8 CFR § 235.13, U.S. Asia-Pacific Economic Cooperation Business Travel Card Program, which was added by DHS-CBP Interim Final Rule published at 79 FR 27161, May 13, 2014 (effective June 12, 2014), which also added the related fee provision at 8 CFR § 103.7(b)(1)(ii)(N).

Designation of Chile for the Visa Waiver Program. By final DHS-CIS rule published at 79 FR 17852, March 31, 2014, the regulations at 8 CFR § 217.2(a) were amended to add Chile to the enumeration of countries designated for the Visa Waiver Program.

DOS Regulations (Volume 2)

Visas: Waiver by Joint Action of Visa and Passport Requirements for Members of Armed Forces and Coast Guards of Foreign Countries. Amendments to the regulations in this regard were made by DOS final rule published at 79 FR 19288, April 8, 2014, amending 22 CFR § 41.3 (amending the introductory text, and the text of subsection (e)).

More 22 CFR Regulations Added: Hague Convention on Protection of Children and Co-operation in Respect of Inter-country Adoption. The DOS Regulations in Volume 2 now include the complete 22 CFR Parts 96 through 99 relating to Hague Convention Inter-country Adoption, replacing what until now has included only selected provisions:

- 22 CFR Part 96—Accreditation of Agencies and Approval of Persons Under the Intercountry Adoption Act of 2000 (IAA);
- 22 CFR Part 97—Issuance of Adoption Certificates and Custody Declarations in Hague Convention Adoption Cases;
- 22 CFR Part 98—Intercountry Adoption-Convention Record Preservation;
- 22 CFR Part 99—Reporting on Convention and Non-Convention Adoptions of Emigrating

Children.
