HIGHLIGHTS

REGULATORY DEVELOPMENTS

- Release 234 is current with regulatory changes published in the Federal Register as of August 18, 2016. See below for details regarding regulatory changes included in this release.

8 CFR Regulations (Volume 1)

Expansion of Provisional Unlawful Presence Waivers of Inadmissibility. DHS final rule published at 81 FR 50244, July 29, 2016 revised 8 CFR § 212.7(e), effective August 29, 2016. The same final rule also made technical corrections to 8 CFR § 103.2(a)(2) & (3), (b)(6) & (7), (b)(9) & (10), & (b)(12), where the text referred either to “an benefit request” or “An benefit request”, correcting the text to read “a benefit request” or “A benefit request”, respectively.

Civil Monetary Penalty Adjustments for Inflation; 8 CFR Parts 270, 274a, and 280. Department of Homeland Security

interim final rule published at 81 FR 42987, July 1, 2016 (eff Aug. 1, 2016), made amendments to the following:

- **§ 274a.10 Penalties.** Paragraphs (b)(1)(ii)(A), (B), (C), and (b)(2), were revised.
- **§ 274a.8 Prohibition of indemnity bonds.** Paragraph (b) of this section, relating to Penalty, was revised.
- **§ 280.53 Civil Monetary Penalties Inflation Adjustment.** Revised in its entirety.

DOL Regulations (Volume 1)

Department of Labor Federal Civil Penalties Inflation Adjustment Act Catch-Up Adjustments. DOL-ETA interim final rule published at 81 FR 43430, July 1, 2016 (eff Aug. 1, 2016), made amendments to the following:

- **§ 655.620 Civil money penalties and other remedies.** Amendments were made to paragraph (a) of this section.
- **§ 655.801 What protection do**

employees have from retaliation? Amendments were made to paragraph (b) of this section.

- **§ 655.810 What remedies may be ordered if violations are found?** Amendments were made to paragraphs (b)(1), (2), and (3) of this section.

In addition to the effective date of August 1, 2016, the interim final rule included information relating to Applicability Dates set forth in the Supplementary Information section of the rule.

The general “Authority” citation in the material for 20 CFR Part 655 as revised by the above interim final rule also reflects a technical correction (correcting the interim final rule) published on July 26, 2016 (81 FR 48700).

DOJ Regulations (Volume 1)

Civil Monetary Penalties Inflation Ad-

justment. Department of Justice interim final rule published at 81 FR 42491, June 30, 2016 (eff Aug. 1, 2016), amended 28 CFR § 68.52, Final order of the Administrative Law Judge, with respect to civil penalties assessed after August 1, 2016.
