• Ch. 91, Requests for Disclosure, has been revised and renamed Required Disclosures.

This release updates Texas Litigation Guide with an updated Chapter 91, revised tables, and a revised index.

Discovery

Required Disclosures. Following from 2020 Texas Supreme Court discovery rule changes, Ch. 91 has been renamed *Required Disclosures* and extensively revised. Under the new required disclosures rule, Civil Rule 194, each party has an affirmative obligation, without awaiting any dis-

covery request, to provide to the other parties a variety of basic information concerning the suit [see Tex. R. Civ. P. 194.1(a)]. This procedure was created by amendments in 2020, effective with respect to suits filed on or after January 1, 2021 [Texas Supreme Court Order, Misc. Docket No. 20-9153, Dec. 23, 2020]. Required disclosures replace requests for disclosure, which were created by 1999 amendments. Under the former request for disclosure procedure, parties were entitled to discovery of much of the same information, but were required to serve requests for disclosure specifying the desired information.
