HIGHLIGHTS

Private Attorney General Act

- Coverage on the role of PAGA, representative and individual wage/civil penalty claims, and arbitration agreements has been updated based on two California Supreme Court cases. See Ch. 5.

- **Coronavirus Pandemic.** New discussion of COVID-19 emergency rules from the Judicial Council has been added (*see* § 1.03[2]).
- **CEQA.** A 2019 case has

been added on how courts should construe CEQA provisions in *Union of Medical Marijuana Patients, Inc. v. City of San Diego* (2019) 7 Cal. 5th 1171, 1184, 250 Cal. Rptr. 3d 818, 446 P.3d 317 (*see* § 5.26).

- **Unfair or Deceptive Practices.** Discussion on whether a claimant is entitled to a jury trial if the government seeks both civil penalties as well as injunctive relief has been updated with *Nationwide Biweekly Administration, Inc. v. Superior Court* (2020) 9 Cal. 5th 279, 292–325 (*see* § 5.51).
- **Private Attorney General Act.** The PAGA discussion

has been updated with *ZB, N.A. v. Superior Court* (2019) 8 Cal. 5th 175, 181–182, 252 Cal. Rptr. 3d 228, 448 P.3d 239, and *Kim v. Reins International California, Inc.* (2020) 9 Cal.

5th 73, 80, 259 Cal. Rptr. 3d 769, 459 P.3d 1123 (*see* § 5.101).

- **Finding Aids.** The Table of Cases, Table of Statutes, and Index have been fully updated in this release.
