 - o Tables Volume 6: This volume will be added to the code and will contain tables for legislative years 2021-2024.
- The Deering's General Index, a two-volume set, that fully integrates references to all the California codes and court rules and is updated and replaced each year. The Deering's General Index replaced the individual supplemental topic indices previously found in the last volume supplement of each code topic

- Each 2025 supplement is a freestanding pamphlet and should be placed in the back of the bound volume or beside the bound volume. It is not designed to fit in the pocket.

Summary of 2024 Legislation through November:

The Legislature reconvened for its regular session January 3, 2024, from which it adjourned on August 31, 2024, and conducted an extraordinary session in October. Across both Houses 1207 bills were passed and enrolled, of which, 1018 were Chaptered by the Secretary of State. Any legislation enacted in another extraordinary session to be convened on December 2, 2024, will appear in your Advance Legislative Service.
