The 2023 Cumulative Supplement updates Michie's Alabama Code Annotated with 2023 legislation through the end of the 2023 Second Special Session, Acts 2023, No. 23-1 through 23-569. The 2023 Cumulative Supplement incorporates the material from the 2022 Cumulative Supplement and 2023 Advance Code Service (ACS) Pamphlets.

Place each pocket part in the back of each corresponding volume. Volumes 7B, 10 and 20 have freestanding paperback supplements, which should be placed beside the corresponding volume. Place one of the generic pocket notices in the back of each of those volumes as a reminder that they do not have a pocket part.

Supplements for Volumes 1, 2, 16, 21 and 21A, which are being replaced this year, are not included in this shipment. Your new volumes will have incorporated the 2023 material and will not have "pocket parts" until the 2024 Cumulative Supplement.

Your complete set of Michie's Alabama Code should contain 51 hard-bound volumes, 3 soft-cover Rules Volumes (Volumes 23, 23A, and 23B), and 2 soft-cover Index volumes, as listed in the checklist below, once the 2023 Replacement Volumes are received in December.
