Remove the 2024 supplements from the corresponding volumes and replace with the 2025 materials. The 2024 supplements may be recycled or retained for historical reference. The user may wish to retain the prior editions of 2025 Revised Volumes 1, 17A, 23, 27 and 34 for historical reference; otherwise, these volumes may be recycled.

Also enclosed is the 2025 Replacement Index to the Official Code of Georgia Annotated, softbound volumes 43, 44, and 45. This index, which includes entries for all codified Acts of the 2025 Regular Session, replaces and supersedes the 2024 Index, which may be recycled or retained for historical reference.

Finally, paste in corrections for 2024 Replacement Volumes 36, 37, and 37A are included with instructions for correct placement included.
