Also, please note that, for the same reason, and because there is no way to annually update them, the individual volume indexes at the back of the replacement volumes have been discontinued, beginning this year. The two-volume Index at the end of the Idaho Code set is updated and reissued each year.

Because of their size, the supplements for Titles 54 and 63-66 are separately paper bound, as they are too large to fit into the back of their corresponding bound volumes.

This shipment includes pocket notice cards to be placed in the replacement volumes and in the volumes containing Titles 54 and 63-66, reminding the user that those volumes do not have pocket-part supplements.
