**Discard** the 2022 Interim Supplement Service pamphlets.

**For interim service** in 2023 of the latest 2023 statutory changes and case notes prior to publication of the April 2024 MCLS Cumulative Supplements, consult both the MCLS Advance Legislative Service issued periodically during the legislative session, and the MCLS Interim Supplement Service which contains case notes, as well as those statutory changes enacted in the 2023 legislative session.
