Former **volume 7 (2014)**, Title 39 was split into new volumes: **7 (2018)**, Title 39, chapters 1 through 13, and **7A (2018)**, Title 39, chapters 14 through end. In addition, former **volume 7A (2012)**, Title 40, chapters 1 through 34 was replaced as **7B (2018)**. As a result of these new volumes, former volume **7B (2014)**, Title 40, chapters 35 through 39 and Title 41, becomes **7C**.

***Please separate the enclosed sticker “7C” from its backing, align it carefully to cover “7B” on the spine of that volume.** The sticker should tightly adhere to the spine, should not be noticeable when the book is shelved, and should easily last until the volume is next replaced.
