The 2017 Cumulative Supplement is current through the 2017 Regular Session of the Virginia General Assembly. The 2017 Cumulative Supplement volumes are in the form of pocket parts and/or freestanding softbound supplements. The 2016 Supplement pamphlets may be recycled or retained for historical purposes.

The 2017 Cumulative Supplement contains all the annotations from the 2017 pamphlets of the Advance Code Service. These pamphlets may now be recycled.

Replacement Volumes 9A and 9B contain material formerly included in the 2012 Replacement Volume 9A and the supplement thereto, which now may be recycled.

New 2017 Edition Index Volumes 12 and 13 replace 2016 Index Volumes 12 and 13. The 2016 Index Volumes may now be recycled.

*There is no supplement for the 2010 Compacts volume. The decision was made to stop producing a separate supplement for the Compacts, because recent efforts by the Virginia Code Commission to codify Compacts have made a separate product unnecessary. New and amended compacts will continue to be supplemented in the individual code volumes. However, there are some remaining historical documents that have not been codified, so the volume should be retained for historic purposes.
