The 2021 Cumulative Supplement contains all the annotations from the 2021 pamphlets of the Advance Code Service and updates included in the 2020 Special Session I pamphlet. These pamphlets may now be recycled.

The Replacement Volume 3 contains material formerly included in the 2016 Replacement Volume 3 and the supplement thereto, which now may be recycled. Volumes 1B, 4, 5 and 6B will be replaced in September.

New 2021 Edition Index Volumes 12 and 13 replace 2020 Index Volumes 12 and 13. The 2020 Index Volumes may now be recycled.
