This package updates the *Annotated Revised Code of Washington*. The code is current with legislation enacted through the 2023 1st Special Session of the Washington State Legislature. These volumes replace the prior volumes and their 2024 supplements, which may be recycled or retained for reference. These five volumes replace the 2018 volume containing Title 41, the 2019 volume containing Titles 49 to 51, the 2020 volume containing Titles 71 to 72, and the 2021 volume containing Title 82. Please note that the volume containing Titles 49 to 51 has been replaced by two 2024 volumes, Titles 49 and 50 and Titles 50A to 51.

The statute text in these volumes was produced from material provided by the Washington Code Reviser. Explanatory notes, cross references, and tables prepared by the Reviser have also been included.
