- A Table of Disposition of Acts, listing individual chapters and sections of acts passed by the Wyoming legislature since 1877 and indicating the W.S. location
- A Table of Comparative Sections, giving the location in the *Wyoming Statutes Annotated* or *Wyoming Court Rules Annotated* of sections that appeared in earlier compilations
- A Table of Revised and Renumbered Sections giving the locations in the *Wyoming Statutes Annotated* of sections that appeared prior to revisions of titles, chapters and articles

The comprehensive index to the *Wyoming Statutes Annotated* is updated and replaced upon publication of each replacement edition and updated upon publication of each supplement. The foreword to the Index explains our indexing principles, suggests guidelines for successful index research, and provides methods for contacting indexers.
