## HIGHLIGHTS

### Included In This Release

- Release 46 updates Bender's Immigration and Nationality Act Service with legislative changes to the Immigration and Nationality Act (INA) and other selected federal immigration-related statutes, as of Pub. L. 114-5, March 7, 2015, 129 Stat. 78. See below for further information.

### Afghan Allies Protection Act of 2009.

This Act is set forth in full at "Section 101, Note 26", following INA § 101. Section 602 of the Act was amended by the Carl Levin and Howard P. "Buck" McKeon National Defense Authorization Act for Fiscal Year 2015 (Pub. L. 113-291, Dec. 19, 2014, 128 Stat. 3292), Div. A, Title XII, § 1227. The amendments:

- (1) replaced the provisions for description of principal aliens at § 602(b)(2)(A) of the Act;
- (2) added a new § 602(b)(3)(F) relating

to numerical restrictions for Fiscal years 2015 and 2016; and

(3) added a new § 602(b)(14) relating to a report by the Secretaries of State and Homeland Security, in consultation with Secretary of Defense, to the Committees on the Judiciary of the Senate and the House.

**Treatment of the Kurdistan Democratic Party and the Patriotic Union of Kurdistan Under the Immigration and Nationality Act.** These provisions are set forth at newly added "Section 212, Note 33" following INA § 212. They were enacted by the Carl Levin and Howard P. "Buck" McKeon National Defense Authorization Act for Fiscal Year 2015 (Pub. L. 113-291, Dec. 19, 2014, 128 Stat. 3292), Div. A, Title XII, 1264.

**Admission/Entry of Government Officials and Family Members Involved in Kleptocracy or Violation of Human Rights.** The most recent enactment in this area is Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-

235, Dec. 16, 2014, 128 Stat. 2130), Div. J, Title VII, Section 7031(c). It has been added to the compilation of similar such provisions which are now collected under “Section 212, Note 20” following INA § 212.

**Extension of Sunset of Travel Promotion Fund Fee.** Sunset of the Travel Promotion Fund Fee was extended from September 30, 2015 to September 30, 2020. See INA § 217(h)(3)(B)(iii), as amended by Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235, Dec. 16, 2014, 128 Stat. 2130), Div. B, Title VI, § 605(b).

**Statement of Policy Regarding Israel; Visa Waiver Program.** See newly added “Section 217, Note 3” following INA § 217 for provisions enacted by the United States-Israel Strategic Partnership Act of 2014, Pub. L. 113-296, Dec. 19, 2014, 128 Stat. 4075, § 9.

**References in Statutes and Regulations to “Public Printer”.** Such references [one of which appears in INA § 282(b)] are now considered to refer and apply to the Direc-

tor of the Government Publishing Office, pursuant to Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235, Dec. 16, 2014, 128 Stat. 2130), Div. H, Title I, § 1301(d). See footnote at INA § 282(b), and also “Section 282, Note 1” following INA § 282(b).

**Terrorist Lookout Committees; Repeal of Provision for Reports to Congress.** Section 304(f) of Public Law 107-173 [8 U.S.C. 1733(f)] was repealed by Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235, Dec. 16, 2014, 128 Stat. 2130), Div. J, Title VII, § 7034(i). The repeal is reflected under 8 USCS 1733 in the Appendix of Selected Non-INA Sections of USCS. Section 1733 relates to Terrorist Lookout Committees to be maintained within United States missions to foreign countries. The repealed subsection (f) related to reports to be submitted by the Secretary of State to appropriate committees of Congress on the status of the lookout committees.
