Release 45A, provided to you at no charge, includes Judicial Council of California Civil Jury Instructions (CACI) that are new and revised as of the June 30, 2006,

Judicial Council meeting. This covers updates that appear in the 2006 supplement to the 2006 Edition of CACI. These separate supplements for the 2006 Edition of CACI are provided to you with this release 45A at no charge.

New CACI

New Fair Employment and Housing Act (FEHA) Instruction. A new instruction has been added to the FEHA series: CACI No. 2527, “Failure to Prevent Harassment or Discrimination—Essential Factual Elements—Employer or Entity Defendant (Gov. Code, § 12940(k)).”

New Damages Instruction. CACI No. 3964, “Jurors Not to Consider Attorney Fees and Court Costs,” has been added to the Damages series. The new instruction is intended to prevent jurors from improperly factoring attorney’s fees into their damage awards.

New Breach of Fiduciary Duty Series.

This release includes a new Series 4100: “Breach of Fiduciary Duty.” These instructions address issues surrounding the breach of fiduciary duties, including an explanation of “fiduciary duty” [CACI No. 4100] and essential factual elements for actions involving the failure to use reasonable care [CACI No. 4101] and the breach of the duties of undivided loyalty [CACI No. 4102] and confidentiality [CACI No. 4103].

New Uniform Fraudulent Transfer Act (UFTA) Series. This release includes a new Series 4200: “Uniform Fraudulent Transfer Act.” This series addresses issues arising under UFTA, including establishing a claim for “actual fraud” [CACI No. 4200] and “constructive fraud” [CACI No. 4202], setting forth factors to consider in determining an actual intent to defraud [CACI No. 4201], and defending an actual or constructive fraud case under UFTA based on good faith [CACI No. 4207] or the running of the statute of limitations [CACI No. 4208].
