Case Law, Statutory Amendments, and Judicial Council Forms

- CHAPTER 32, Jurisdiction to Determine Custody and Visitation: Revised to add new subsections on *Emergency and Non-Emergency Custody Orders under the Domestic Violence Prevention Act*
- CHAPTER 95, Procedures for Temporary Orders and Relief: Updated to discuss *Electronic Service* and *Remote Appearances*, and includes new Judicial Council forms for Remote Appearance
- CHAPTER 96, Injunctive

Relief Against Domestic Violence: Updated throughout to discuss new case law and statutory amendments; includes revised JC forms

- CHAPTER 111, Pretrial Procedures: Revised to include a new subsection on *Unsealing Court Files*
- CHAPTER 141, Special Remedies for Enforcement of Support: Revised to discuss *The Role of Child Support Agencies* in civil enforcement and *Uncollectible Arrearages* under Fam. Code § 17400(a)(2)
