2014 Highlights Include:

Introductory Note: In 2012, the Virginia General Assembly passed legislation, which was approved by the Governor on April 4, 2012. The legislation, which became effective in October 2012, created Title 64.2 (Wills, Trusts, and Fiduciaries).

Title 64.2 is a revision of existing Titles 26, 31, and 64.1, as well as other titles of

the Code, which deal with fiduciaries and estate administration. Title 64.2 consists of 27 chapters divided into five subtitles:

In 2014, additional changes were made to the Virginia law. Those changes are also reflected in the update.

For this Supplement, several references to the revised statutes have been updated and included in the sections of text; however, a future edition of the treatise will provide comprehensive updates to the present statutory references in Virginia. In the interim, for your convenience, with a grateful acknowledgment to David Cotter, Division of Legislative Services, Commonwealth of Virginia, who was instrumental in the work of the Virginia Code Commission recodification of Title 64.2, the reference tables, which reflect the comparable provisions in Titles 64.1 and 64.2, have been retained.

In addition to the changes made to reflect new cases and laws, highlights for this release include:

Appointment of Administrator for Prosecution of Personal Injury or Wrongful Death. A discussion has been added to reflect the Virginia Code provisions governing appointment of an administrator for the prosecution of a personal injury or wrongful death suit on the part of a decedent. Such appointment is permitted under the provisions of § 64.2-454 of the Code of Virginia. [See § 12.12.]

Inventory and Appraisement. Chapter 13, relating to the inventory and appraisement provisions in Virginia and West Virginia, has been restricted to enhance user friendliness and ease of use. *See* Ch. 13.
